SUBJECT: Committee on Committees Monthly Report

Senate Membership:

There are two vacancies and the Committee on Committees would like to inform the Academic Senate of the election of two new senators: Professors Jenny Lin-Martinez and Regina Sullivan.

Explanation: Lorena Ellis (Foreign Languages) is on leave for one semester and Jannette Urciuoli is on leave for a full academic year. Next on the list of vote totals is Jenny Lin-Martinez (also Foreign Languages.) Lin-Martinez needs to replace Ellis because Ellis will be back in the Spring and will resume her term in the Senate. Foreign Languages already has its maximum number of Senators (5 – according to the Bylaws.) With Lin-Martinez receiving a one semester appointment to the Senate replacing Ellis and with Ellis then returning in the Spring, Foreign Languages (with Lin-Martinez leaving) maintains (and does not exceed) its maximum number of members.

Jannette Urciuoli will be replaced by the next person on our list (according to the vote totals): Regina Sullivan (Biology.) This is a one year replacement because Jannette's term expires Spring '06.

Standing Committee Membership:

Pat Allaire (Mathematics) is on leave and needs to be replaced on the Course and Standing Committee. The Committee on Committees has voted to replace her with Assistant Professor Jilani Warsi (Basic Skills.)

Elaine Della Vecchia (Nursing) is leaving the College and needs to be replaced on the Ceremonial Occasions Committee. The Committee on Committees has voted to replace her with Assistant Professor Margaret Mikowski (also from Nursing.)

Vacancy on the Committee on Committees:

Jannette Urciuoli's leave has created a vacancy on the Committee on Committees. The committee requests that the Academic Senate vote to approve a replacement.
