While the names of these individuals have been omitted from the minutes, the Steering Committee wishes to indicate that these names are available to any and all who may be interested to know, and that the Steering Committee is pleased to make them available upon request, as we are required by law to record the names and votes of members of the Academic Senate, just as members of the standing committees of the Academic Senate are required to record their votes and make them available upon request, as per Article II Section 8 of our By-Laws: *Record of Final Votes*:

The Freedom of Information Law requires that a public agency must maintain a record of the final vote of each member in every agency proceeding in which the member votes. In order to minimize delay, especially on uncontroversial matters, several motions may be grouped together for a single vote and/or the chair may seek unanimous consent of the members present. All senate votes will be recorded and the minutes will note those who vote in the negative or who abstain.

As Senators utilize our clicker system to register their vote, the Steering Committee also wishest to take this opportunity to respectfully remind all Senators who choose to abstain from a vote that the correct way to do so is to press "C" on your clicker. Unfortunately,

if a senator elects to abstain by not voting, neither the abstention nor the Senator can be counted toward the quorum needed for our governance body to function.

## 2. Committee Matters: Composition and Membership

#### 3. Committee Matters: Activities

- As of this writing, the Steering Committee has formally met with the chairs of all committees of the Academic Senate, and reviewed the various components of end-of-year procedures, including the election of new committee chairs and the preparation of annual reports. The Steering Committee, in concert with the Committee on Committees, has also been at work on a few modifications to the current committee guides that will address thorny issues such as the particulars of "paperless" on-line elections, and the template the Committee on Committees uses for assigning faculty to committees. The Steering Committee would like to thank all outgoing chairs of committees of the Academic Senate for their dedication and hard work. We are grateful for their guidance, and their commitment to shared governance.
- As of this writing, the Special Committee to Develop On-Line Education has prepared a final report that summarizes both its transactions, and its recommendations, some of which the Steering Committee is delighted to report have already inspired steps to create more on-line education opportunities for our students. These include current plans to collaborate across the campuses of the City University

- of New York's six community colleges for the possible eventual launch of an on-line Associates degree program. The Steering Committee would like to thank all the members of this special committee, with special thanks to its chair, Dr. Edward Volchok, for his vision and energy.
- Members of the Academic Senate will note that one item has been placed on this agenda, under "Old Business" that will require a vote: consideration of the Assessment Handbook, which has been offered as an appendix to this report in Attachment J/1 and J/2. A resolution related to this action is also included, Attachment K.

# 4. College Wide and University Matters

A final consideration of the University Faculty Senate Experience Survey, designed and implemented by Dr. Kathleen Barker, a professor of Psychology at Medgar Evers College, CUNY, shows several areas of concern at Queensborough, including concerns about office space, and the availability of sabbaticals. The Steering Committee of the Academic Senate wishes to thank President Marti, Provost Call, and Faculty Executive Committee Chair, Dr. Sheena Gillespie, who have indicated their willingness to participate in a meeting with members of the Queensborough College Executive Team to consider ways to address these various concerns, which the Steering Committee hopes will be coordinated either before the commencement of annual leave or at a point during the fall of 2010.
